

ADAPTATION LICENSE REQUEST

Beckenhorst Press, Inc. or The Music of Dan Forrest

This license allows you to create small customizations of our music (including choral or instrumental parts), in ways that require writing out new music, such as simplifying choral parts for a small men's section, adding one obbligato instrument to a piece, or creating your own audience/congregational part to be printed in your bulletin/program. Please note:

- Merely marking a purchased copy does not require a license. Use this license only if you need to write out a new part.
- **This license does not replace purchasing copies of our existing product;** you are required to purchase the full number of copies needed for your choir and/or instrumentalists; if your adaptation license is approved, you may then print your newly created material as needed for use along with our product.
- **For instrumental ensemble arrangements** (i.e. creating versions or accompaniments for string quartet, brass quintets, string orchestra, chamber orchestra, full orchestra, wind band, etc., not just one solo instrument) **please use the Orchestration License instead.**
- **For arranging or revoicing choral parts for an entire piece** (creating a new version, not just adapting one section), **please use the Choral Arranging License instead.**
- **The publisher retains all rights and control of any work created under terms of an Adaptation license.** An Adaptation License does NOT grant permission for any sharing or distribution of your created work, in print or recorded form. (If you wish to share or distribute your work for use by anyone else, please contact the publisher for details. Depending on the situation, we may require a separate print license, mechanical license, or other license.)

If permission is granted, we will provide details for payment.

If licensee fails to abide by the terms of this license, provide required accounting, or make payments, the publisher may provide written notice of intent to terminate/revoke this license, and if the default is not remedied within 30 days, the license will be revoked/terminated, and any continuation of any previously licensed activities will be actionable as acts of infringement against the United States Copyright Act.
