

# PRINT LICENSE REQUEST

## Beckenhorst Press, Inc. or The Music of Dan Forrest

This license allows you to reprint our music and lyrics, (i.e. in a songbook). (For printing lyrics only, please use the Lyric Reprint License instead.) Digitally distributed copies cost the same as printed copies, and require an initial non-refundable advance payment. Please read all of the following carefully, and contact us if you have further questions.

- **Our copyrighted material may not be adapted or altered in any way** without permission or adaptation/arrangement license.
- **Print licenses do NOT include permission to collect mechanical license income or performance royalties on the work printed** (whether our original or your derivative work-for-hire created under an arrangement or orchestration license). These rights and revenues are retained and collected by the original publisher, and must be referred to them. This license, once granted and paid, only grants permission to print music and collect revenues on its sale.
- Print Licenses for Beckenhorst Press publications (product codes beginning with BP, CU, JH, or HB) **in Korea, or in Korean translation, are exclusively handled by Jang Choi** at Sunmin Music, jang@sunmin.co.kr. (This does not apply to DF or EH products.)
- The fee for a print license is **12.5% of the retail cost of the music, prorated by the number of copyrights in the book.** (Should you pay any other licensor a higher royalty than 12.5%, you will need to pay Beckenhorst Press the same amount.)
- **Payment must be made for the entire print run at the time of each printing.** For subsequent printings beyond the first print run, please contact us for either a new license or an extension of the initial license; payment is always based on total print run (not sales).

- **This license also covers distribution and sale of DIGITAL EDITIONS** of the composition, online or in other electronic media. These digital editions must include the same copyright info listed above. **An initial advance payment of \$50.00 toward future downloads is required** (in addition to any printed-product license payments), and accounting and payment are required annually (at least) for as long as the product is available digitally.
