We want conductors to have an outstanding experience working with us, and we make every effort to ensure that rental scores and parts are delivered in clean condition and in a timely manner to each customer. We ask that you help us by adhering to the following terms and conditions:

1. Rental fees are not prorated or discounted for rentals shorter than the standard 6 weeks.
2. There is no fee if you cancel a rental before your rental ships. **If we receive your cancellation notice after your rental has been shipped, a \$100.00 cancellation fee plus our shipping/handling charges will be deducted from your rental refund.** All remaining rental fees will be refunded once your rental is returned.
3. We ship clean parts and scores; the only marks we leave are neat/helpful string bowings that can easily be changed by the next renter if needed. Please ask your players to mark only in pencil, and please erase extraneous marks before returning. **In short, please return the music in a condition that you would want to receive if you were the next renter.** We reserve the right to charge an hourly fee for erasing messy returned parts, or a replacement fee if parts are un-erasable or returned in poor condition.
4. **Please double check your rental return against the checksheet that we will provide,** to be sure score and all parts are included. Missing parts will be charged a replacement fee of \$20 per part; missing conductor's score will be charged the purchase price (\$150).
5. You are responsible for return postage. **Please return all material via UPS or traceable mail within two weeks after your performance.** It is very important that your return be traceable as you will be liable for replacement cost (a full rental fee) of any rental material that is lost and not traceable. Materials not received within 3 weeks of the performance date (4 weeks for Canada) will be assessed an additional \$50 per week until it is received.
